Dear Secretary Hegseth:

I write regarding the recent announcement of a Letter of Acceptance allowing the Qatari government to build a temporary Qatar Emiri Air Force facility at the Mountain Home Airbase in Idaho. <sup>1</sup> The U.S. has maintained a productive relationship with Qatar, including the use of the Al-Udeid Air Base in Qatar as the regional headquarters for U.S. Central Command. <sup>2</sup> Unfortunately, due to the many entanglements—at least some of which are clearly unlawful—that President Trump, his family, and his associates have with Qatari interests, oversight is appropriate even for agreements between our country and Qatar that followed proper channels. <sup>3</sup>

As ranking member of the Committee on Oversight and Government Reform's Subcommittee on the Military and Foreign Affairs, I request a briefing on this agreement to ensure that this deal best serves American national security interests. In addition, please confirm that no official recused from matters involving the State of Oatar was involved in this agreement.
