Dear Mr. Armstrong:

Please be advised that an investigation is underway regarding the Trump Administration's use of unauthorized messaging platforms for government business. As a social messaging platform with private messaging capability, X Corp. (X) is in possession of information and records that are critical to this investigation and any related investigation. Accordingly, this letter services as formal notice to preserve and not alter, delete, destroy, or otherwise dispose of any and all documents, communications, materials, and electronically stored information (ESI) that may be relevant to this matter.

This preservation obligation extends to all documents, communications, and ESI in your possession, custody, or control from January 20, 2025, including but not limited to:

• All private messages on X between or among Trump Administration officials, including President Trump;

- All private messages on X between or among Trump Administration officials, including President Trump, and foreign government officials;
- All private messages on X sent by Trump Administration officials, including President Trump, that discuss official U.S. government business;
- All accounts on X belonging to Trump Administration officials, including President Trump;
- Backups and archived data;
- Electronic documents;
- Server logs and system data; and
- Social media content and metadata.

This notice applies to all data regardless of where it is stored or by whom it is held, including personal devices and third-party platforms (e.g., cloud storage, third-party communication tools). Immediately suspend any automatic or routine document destruction policies, including email deletion protocols, shredding schedules, data overwriting processes, or automatic message deletion that may result in the loss of potentially relevant information.

The Committee on Oversight and Government Reform is the principal oversight committee of the House of Representatives and has broad authority to investigate "any matter" at "any time" under House Rule X.
