Dear Secretary Rollins:

We write regarding the planned relocation of U.S. Department of Agriculture (USDA) core personnel and functions out of the National Capital Region. The ability of USDA to fulfill its mission is critical not only to our nation's farmers, ranchers, and rural communities, but also to ensuring the safety of our food and natural resources. Given the Department's lack of consultation with Congress to date regarding this reorganization plan, we are deeply concerned that this relocation, like many other reorganization efforts attempted by this administration, is being implemented without appropriate study of the costs and benefits to USDA or the American people. To assist Congress in its oversight function during the statutorily required 30-day consultation period, we look forward to your providing additional information regarding what analysis USDA has conducted to ensure this plan is in the best interest of USDA, the rural communities it serves, and the American taxpayer.<sup>2</sup>

The Administration's cuts to USDA's workforce and upheaval caused by relocating offices and functions to other parts of the country could reduce USDA's capacity to provide essential services and perform the research critical to the maintenance and safety of America's agricultural sector.<sup>3</sup> This is precisely what happened in 2019, when President Trump directed USDA to relocate two agencies from Washington, DC to Kansas City, Missouri.<sup>4</sup> As the Government Accountability Office (GAO) found in 2022, USDA failed to consider critical costs

and economic effects in its analysis of the costs and benefits of moving agencies from Washington, DC. GAO also found that the offices that were relocated had reduced productivity and USDA was left with a less experienced workforce. GAO found that it took USDA two years to recover from the upheaval caused by the move.<sup>5</sup>

Our nation's farmers, ranchers, and rural communities cannot afford to wait years for critical services from USDA, nor can they afford a degradation of USDA expertise. According to agricultural industry reporting, stakeholders are concerned about a range of negative effects of the reorganization, including a loss of institutional knowledge and capacity resulting in service disruptions to farmers.<sup>6</sup>

Without rigorous analysis, stakeholder consultation, and planning, any large-scale relocation of USDA could leave the agency without the personnel, expertise, and resources needed to effectively serve agricultural and rural communities. The Administration's actions prior to the announcement of this planned relocation have already significantly hindered USDA's ability to carry out its missions. For example, USDA has left critical specialist roles vacant, resulting in diminished capacity, including a 20% reduction in staffing at the Natural Resources Conservation Service (NRCS).<sup>7</sup> As stakeholders recently testified, NRCS plays a crucial role in assisting farmers and ranchers in proactively managing their land, and NRCS programs are frequently oversubscribed, with demand outpacing funding and staff capacity.<sup>8</sup> As a result of the Trump Administration's treatment of the federal workforce, NRCS has lost nearly 2,400 employees since January, resulting in higher workloads for staff and reduced capacity to process program applications from farmers and other producers.<sup>9</sup>

Although we appreciate Deputy Secretary Vaden's appearance before the Senate Agriculture, Nutrition, and Forestry Committee on July 30, 2025, to testify on the reorganization plan, his testimony leaves significant areas of concern about USDA's level of analysis or lack thereof into the impacts of the plan. At multiple points in the hearing, Deputy Secretary Vaden testified that USDA has no estimate of what the staff attrition rate will be from this plan, stating, "it's hard for me to predict how many will [relocate]" and that "we don't have a specific number to offer [on estimated employee attrition] at this time." Given the results of USDA's prior relocation efforts, USDA has clearly failed to learn the lessons it should have from the disastrous 2019 reorganization. Our nation cannot afford another rushed relocation.

Given USDA's critical role in supporting our food system and agricultural industries, it is urgent that Congress understand not only the details of USDA's planned reorganization but also the goals and analysis underpinning those plans. To assist Congress in its oversight, we request that USDA provide the following information and documents no later than August 21, 2025:

- 1. A timeline and all documents and communications related to all employee engagement efforts regarding the proposed reorganization and relocation and resulting analysis;
- 2. A timeline and all documents and communications related to all stakeholder engagement efforts regarding the proposed reorganization and relocation and resulting analysis;
- 3. All documents and communications related to any benefit-cost analysis and any other analyses conducted in support of USDA reorganization plans, including:
  - a. The goals, anticipated outcomes, and improvements that will result from the reorganization and planned metrics for determining whether the improvements are achieved;
  - b. Workforce planning analysis, including identification of critical skill gaps and forecast of future needs;
  - c. Comprehensive analysis of relocation and reorganization costs, including employee and office/equipment relocation expenses, leasing costs, productivity loss, travel costs, and costs to stakeholders;
- 4. All documents and communications related to USDA's reorganization plans, to include:

- a. USDA's Agency Reduction-in-force and Reorganization Plan responsive to the Office of Management and Budget and Office of Personnel Management memo of February 26, 2025<sup>11</sup>;
- b. Implementation timeline identifying milestones and the persons accountable for meeting such milestones;
- c. A detailed breakdown of the budgetary resources needed to implement the reorganization and alignment of those costs with appropriated resources;
- d. A detailed description of functions and offices proposed for elimination or reduction;
- e. Assessment of risks related to reorganization and risk mitigation plan; and
- f. Documentation of succession, transition, and recruiting plans to ensure maintenance of core functions.

The Virginia and Maryland congressional delegations represent thousands of USDA employees. The Committee on Oversight and Government Reform is the principal oversight committee of the House of Representatives and has broad authority to investigate "any matter" at "any time" under House Rule X.
